1.	In context of RFP clause 6(a) and ToR section 3, 10% of Performance Guarantee includes the cost related to Optional Mauzas, 15% reverification and FM verification. However, these three items may or may not occur. Therefore, it is suggested that cost of these items may be taken out from the calculation of Performance Guarantee.			
	USF shall require the successful bidder to furnish a performance guarantee which shall be ten (10%) per cent of the contract amount. USF considers that the mode			

	and manner of Performance Guarantee calculation adequately safe guard the interest of both parties, therefore no change is deemed necessary.
2.	Reference RFP clause 3(h), Annual turnover in numbers is PKR 25,000,000 whereas in words it states Pak Rupees Fifty million only. Please clarify.
	It was clarified that it's a typo and annual turnover amount in words be read as "Pak Rupees Twenty Five million only"
3.	Reference ToR Part 4 regarding Payment Terms it is stated that "Mobilization advance amounting to 20%; payable within thirty (30) business Days of Effective Date against a bank guarantee of the similar amount.". Please clarify weather the effective date is signing date of contract or the submission date of bank guarantee.
	It was clarified that bank guarantee is required only in case TA asks for a Mobilization Advance. Furthermore, Mobilization advance will be payable within thirty (30) business Days from the date of submission of bank guarantee.
4.	Reference to RFP Clause 6(c) "the delay shall lead to the imposition of Liquidated Damages @ 0.5%(PKR) per week on the Technical Auditor" Kindly clarify the unit PKR written with the percentage?
	It was clarified that it's a typo the above may be read as "the delay shall lead to the imposition of Liquidated Damages @ 0.5% per week on the Technical Auditor"
